- II. **Meeting called to order:** 6:31 pm by Bobbi Jo Ferguson.
- III. **Roll Call:** Sue Barnaby, Treasurer; John Berglund, Trustee; Bobbi Jo Ferguson, Clerk; Jerry Wuorenmaa, Trustee; James Bucknell, Attorney. Not present: Jack Otlewis, Supervisor.
- IV. **Meeting Leader:** A motion was made by Jerry Wuorenmaa, Trustee to run the meeting in the absent of the Township Supervisor. A second was made by John Berglund, Trustee.
